The REIQ Contract which is the main form of contract for the sale of residential land in Queensland, provides for the sellers and buyers signatures to be witnessed. There is no strict legal requirement for signatures to be witnessed on a contract for the sale of residential land. Accordingly, your contract will not be void by the fact that a signature has not been witnessed.

A contract is a legally binding agreement. It can be verbal (ie spoken), but some contracts must be in writing. It's possible for a contract to be partly written and partly verbal.
